ORDER

This matter was heard on 27 July 2010 by the Honorable M. Michael Monahan, District Court Judge, on: (a) Defendant's motion for summary judgment (Court Docket 28); and Plaintiffs' Rule 56.06 motion for a continuance (Court Docket 34).

Plaintiff Delin Qu appeared *pro se* and for Plaintiff Hong Chen.

Jodee K. McCallum of Thompson, Coe, Cousins & Irons, LLP, and John Ross made submissions and appeared for Defendant Mar. Ms. McCallum argued.

Based on the entire record in this matter:

IT IS ORDERED that:

1. Plaintiffs' motion for a continuance is **DENIED**. Plaintiffs have failed to demonstrate any rational need for additional discovery in order to justify their opposition to this motion for summary judgment.
2. Defendants' motion for summary judgment is **GRANTED**.
3. All further activity in this action is **STAYED** until the entry of the appropriate order for judgment in due course.
4. I grant Defendants' motion for summary judgment without an accompanying memorandum in order to protect the parties from further litigation expense and, frankly, from

being subjected to further unwarranted litigation annoyance. A memorandum supporting this order, making appropriate findings, and ordering the entry of an appropriate judgment will follow in due course. I will not elaborate why I conclude that this unusual action is necessary other than to say that Plaintiffs have been engaged in meritless litigation that simple justice demands be curtailed.

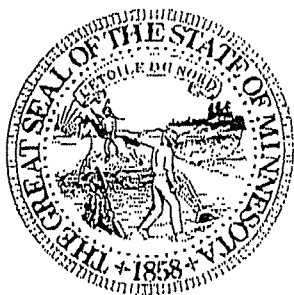
